**TERMS & CONDITIONS**

**GENERAL GUIDELINES :**

The tender should contain all the relevant information required.  
Tenderer should not be debarred to participate in the tender by the Madhya Pradesh Government or any of its undertaking, Corporation, Board or should not have been barred by any law.  
Tenderer should not be minor, mentally ill or insolvent.

**NUMBER OF TENDERS**

1.2.1 Each Tenderer/s shall submit only one (1) tender, in response to this Invitation for Tendering. Any tenderer, who submits or participates in more than one Tender, will be disqualified.

**TENDER PREPARATION COST**

1.3.1 The Tenderer shall be responsible for all of the costs associated with the preparation of its Tender and its participation in the tendering process. MPSTDC will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the tendering process.

1.3.2 It would be deemed that by submitting the Tender, the Tenderer has received all relevant information requested from MPSTDC.

1.3.3 MPSTDC shall not be liable for any mistake or error on the part of the Tenderer in respect of the above.

**2.1 EARNEST MONEY :**

2.1.1 The Tender should be accompanied by an Earnest Money Deposit (EMD) of Rs. Five Lakh only (Rs. 5,00,000/-)

2.1.2 The EMD shall be in favour of MPSTDC in the form of:

- Demand Draft/Bankers Cheque/Bank Cash Order issued by a Scheduled Commercial Bank of India, payable at Bhopal.

2.1.3 The EMD shall be returned to the unsuccessful Tenderer within a period of two (02) weeks from the date of opening of the Tender.

**3.1 FORFEITURE OF THE EMD :**

The EMD shall be forfeited if the tenderer withdraws his offer after submission of the Tender.

**4.1 TENDER VALIDITY PERIOD :**

4.1.1 Tender shall remain valid for a period not less than 90 days from the Tender Due Date.

4.1.2 After issuing of LOA the Tender Validity Period for successful bidder shall deem to have been extended till the date of completion of the whole process.

**5.1 TENDER DUE DATE :**

5.1.1 The tender should be submitted on or before 03 April, 2010 till 1500 hours at the address - General Manager(Water Sports), MP State Tourism Development Corporation Ltd, Paryatan Bhawan, Bhadbhada Road, Bhopal - 462003 (Madhya Pradesh)

**6.1 SUBMISSION OF TENDER :**

6.1.1 The tender should be submitted in two parts in separate envelopes

**Envelope A shall content :**

- a) Covering Letter
- b) Tender form - Annexure 1
- c) Anti-Collusion Certificate - Annexure 2
- d) Demand Draft of EMD

**Envelope B shall content :**

- a) Financial Bid as per the format set out in - Annexure 3

6.1.2 The tenderer shall seal the envelop marked as ENVELOPE 'A' "TENDER FORM". The second envelope will be marked as ENVELOPE 'B' " FINANCIAL OFFER'. Envelope A & B will be kept in a cover envelope marked as "ENVELOPE C".

6.1.3 Each envelope shall indicate the name and address of the tenderer.

6.1.4 Envelope should be so sealed that the contents are not visible to the naked eye and they can only be opened after tearing from either side.

## **7.1 TECHNICAL SPECIFICATIONS :**

7.1.1 Cruise Boat should be twin deck and be FRP(Marine Grade) Catamaran Hull with the superstructures indigenously designed to match a traditional Pirate Ship. A photograph suggesting the possible appearance is attached.

7.1.2 Length of Hull not less than 70 ft, beam 18 to 20 ft, Draft at full load 3 to 4 ft.

7.1.3 Speed 10 to 12 knots. Capacity 90 + compliment 10.

7.1.4 SS Safety Railings all around, Canopy on top deck. AC Bridge.

7.1.5 Two latest John Deer 200 HP 6 cylinders marine engines with hydraulic gear box.

7.1.6 One 6.5 KVA silent marine John Deer marine Genset with anti vibration mounts and installed in the Hull.

7.1.7 Three CQR anchors.

7.1.8 Fenders, navigation lights and horns as required.

7.1.9 Fuel tanks endurance 8 hours.

## **7.2 OTHER REQUIREMENTS:**

7.2.1 The bidder should be a manufacturer and should have manufactured minimum 4 such cruise boats, which are in operation for past 4 years. The proof for same must be submitted.

7.2.2 The cost must include Launching and commissioning of Cruise Boat at upper Lake Bhopal with 15 days sea-trials before handing over.

7.2.3 It should have an AC hall for Restaurant 40 pax, capacity, one pantry, one store. Toilet with arrangements for waste disposal ashore.

7.2.4 100 Life Jackets and 10 life buoys.

7.2.5 Engine room to be noise and vibration proof. It should be well ventilated with sufficient space for work and sufficient head room for maintenance.

7.2.6 The Drawings and plan of the Boat should be submitted.

7.2.7 A model of the proposed boat may be submitted

## **8.1 EVALUATION OF THE FINANCIAL BID :**

8.1.1 The Financial Bids of all the Tenderers who pass Stage 1 of Tender evaluation shall be opened in the presence of the Tenderers' representatives who choose to attend. The Tenderers' representatives who are present shall be required to sign and record their attendance.

8.1.2 The Tenderer Quoting the Lowest Bid may be declared the successful bidder.

8.1.3 In the event that two or more Tenderers quote the same amount, MPSTDC may :

a. invite fresh Bids from the Tenderers;

OR

b. take any such measure as may be deemed fit in its sole discretion, including annulment of the Tendering process.

## **9.1 LATE TENDER:**

9.1.1 Any Tender received by MPSTDC after 1500 hours IST on the Tender Due Date will be marked as Late Tender and returned unopened to the Tenderer.

## **10.1 NOTIFICATION :**

(a) . Notwithstanding anything contained in the Tender document, The MP State Tourism Development Corporation Ltd. reserves the right to accept or reject any Tender and/or to annul the Tendering process and reject all Tenders, at any time without any liability or any obligation for such acceptance/rejection or annulment, without assigning any reason, thereof.

- (b). The MP State Tourism Development Corporation Ltd reserves the right to invite fresh Financial Bid with or without amendment of the Tender document at any stage, without liability or any obligation for such invitation, without assigning any reason, thereof.
- (c). The decision of the Managing Director, MPSTDC shall be final and binding on all participating Tenderers.
- (d). The decision of the MPSTDC on the Bid Evaluation Report will be intimated by MPSTDC to the successful Tenderer.
